

The Ministry of Textiles invites sealed bids for the award of Annual Contract for dry cleaning/vacuum cleaning/cleaning of Sofa Sets/Cushion chairs/rooms/ floors etc. on annual basis through open tender enquiry. The details of dry cleaning/vacuum cleaning/cleaning of Sofa Sets/Cushion Chairs/rooms/floors etc. are given in Annexure-I.

- 2. The following are the terms and conditions for the firms for submission of bids.
 - (a) The firm should be a reputed firm having its registered office.
 - (b) The firm should be registered with the GST.
 - (c) The firm should have a minimum of three years experience in the business of above mentioned items with the Central Government Ministries/ Department, PSWU, Statutory/Autonomous Bodies etc.
 - (d) The firm should have a valid PAN Number.
 - (e) The firm should have minimum annual turnover of **6** (six) lakh during each of the last three years.
 - (f) The owner/proprietor/manager of the firm should be available on his own direct telephone number (office as well as residence) and also on mobile phone as and when contacted.
 - (g) The contract will be awarded for a period of **one year which may be extended or curtailed** subject to satisfactory performance of the firm.
 - (h) In case the selected firm is not able to provide satisfactory service to this Ministry in time during the currency of the contract, the Ministry may terminate the contract and also forfeit the Performance Security.
 - (i) The bidding firms are required to submit Technical Bids and Financial Bids. The Financial Bids of only those firms shall be opened who qualify technically.
 - (j) The firms should quote unconditional rates strictly as per list of work. There should be no cutting/overwriting in the bids.
 - (k) The bidding firms are required to deposit Bid Security (Earnest Money) of Rs.5,000/- (Rupees five thousand only) in the form of Bank Draft in



- (I) The successful bidder will have to deposit Performance Security Money for an amount of Rs.10,000/-(Rupees ten thousand only) in the form of an Account Payee Demand Draft/ Fixed Deposit Receipt from a commercial Bank, Bank Guarantee from a commercial Bank in an acceptable form safeguarding this Ministry's interest in all respects. Performance Security should remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the firm including warranty obligation. Bid security of the successful bidder will be refunded on receipt of Performance Security.
- (m) The Ministry reserves the right to accept or reject any or all the bids without assigning any reasons thereof.
- 3. Interested and eligible firm may submit Technical and Financial Bids (In prescribed Formats as given in Annexure-II & Annexure-III) in separate sealed covers. Both these covers should be further sealed in a separate cover which should be superscripted "Bid for Annual Contract for Dry cleaning/vaccum cleaning/cleaning of Sofa Sets/Cushion chairs/rooms/floors etc." addressed to the Under Secretary (Admn.), Ministry of Textiles, Room No.29-B, Udyog Bhawan, New Delhi and should reach him/her latest by 03.00PM on 25th October,2019. Bids received after the stipulated date/time shall not be entertained. The bids will be opened on 25th October,2019 at 03.30 PM in room No. 29-B, Udyog Bhawan, New Delhi in the presence of the bidders or their representatives who may wish to be present.
